We have gone to great lengths and gathered the experience and wisdom of many longtime Valley-Dynamo employees through the years to provide this resource. Some folks call or write immediately, without looking, without checking. You are truly a concerned individual who is eager to learn, and we hope the past ten years of refining this document in response to additional customer questions will result in time well spent for you. THANKS.

WE ARE NOT A FULL-LINE PARTS SUPPLIER – yes, if you're on the Dynamo FAQ page, Dynamo is probably your area of interest. But so it's "out there", we make Dynamo, Valley and Connelly pool tables and only stock parts for Dynamo, Valley and Connelly tables.

BEFORE CONTACTING VALLEY-DYNAMO we have a serious Spam/E-mail filter. If you send an e-mail with no title or an unsolicited e-mail with an attachment, or copy a lot of people on your note, it may not get through. Always title your e-mail, e-mail only the most appropriate party, and contact us first prior to sending large attachments such as photos. Gmail has issues with us so maybe make sure @valley-dynamo.com is a "Safe sender." If you looked here and still could not find the answer you seek (and since we wrote this, we'll for-sure know if you actually looked), [click on this link to contact us](#) .

FIRST – we've had entire conversations where the table is referred to as a "Dyman" – even after we pronounce it correctly.

DY – NA – MO - Spelled that way, said that way. Even before 1973



"I HAVE AN OLD VALLEY-DYNAMO POOL TABLE..." – Wait. No, you don't. Stop. there is no such thing. Valley and Dynamo tables are separate products. Look no further than a Dynamo 7-foot table built prior to 1993 is a "Model 37" AND a Valley 7-foot table built from 1979-1981 is ALSO a "Model 37". Since Valley and Dynamo merged, we've shared some components, but



these tables were designed separately by competitors. Before you contact our Technical Support department, our Parts Sales department, your distributor, or any local pool table service pro; know for sure whether your table is Valley or Dynamo.

IMPORTANT: Does the corner casting say Dynamo?

HOW OLD IS MY DYNAMO TABLE? Dynamo Serial numbers were not as well-documented as Valley. (they were once documented pretty well – but in computerized records we lost the ability to access almost 20 years ago). As a result, we cannot pinpoint the exact age of *almost any* older Dynamo table. The good news is that Dynamo Pool tables have changed less over the years, and parts availability will not be a big issue.

AS WE ALSO SAY FOR VALLEY, TORNADO, CHAMPION AND CONNELLY TABLES....

- WE NO LONGER HAVE ALL PARTS FOR EVERYTHING WE'VE EVER MADE.
- WE OFTEN DO NOT HAVE AN ALTERNATIVE IF THE ORIGINAL PART IS NO LONGER AVAILABLE- YOU WILL HAVE TO "GET CREATIVE" TO KEEP A TABLE IN WORKING ORDER THAT IS THAT OLD WITH NO PARTS
- SOMEONE MAY ALREADY HAVE GOTTEN CREATIVE – WE CAN ONLY ASSUME THAT TABLE REMAINS "AS IT LEFT OUR DOCK" AND HAVE NO WAY OF KNOWING IF THERE HAVE BEEN CUSTOM UPDATES

MODEL #7 VS. MODEL #8 – WHAT'S THE DIFFERENCE? Notice how Dynamo tables are "model 37 and 38" or "model 47 and 48." Any models ending with a "7" signify Weighted Separator production and are 1995 or older. Models ending with an "8" are Magnetic Separator production and are 1993 or newer. IN MOST CASES. And between 1993 and 1995, we built both.

JUST HOW BIG OF AN ISSUE IS PARTS AVAILABILITY?



Prior to 1981, all bets are off.

We found this wonderful flyer with a lot of changes made for 1981.

1 – BALL DROP SYSTEM – this has subsequently changed from aluminum ramps to ABS plastic. The Ball Flap and Ball Ramp mentioned are still in current use

2 – BALL SEPARATOR – This was phased out starting in 1993 and since 1995 EVERY Dynamo coin table uses a magnetic cue ball separator.

3 – CAST ALUMINUM LEG LEVELERS - remain unchanged

4 – COIN MECHANISM – the breakdown shows this is wooden (at left) and not the ABS plastic currently used (at right). Assume the parts are no longer available



If your coin door looks like the photo to the left with the rounded surround and no plastic frame, parts **are no longer available and haven't been for over 25 years.**

Coin doors like the one on the right are the current style. Parts are available.



5 – NEW LEGS SYSTEM – the legs have changed again, but all indications are the current bolt-hole pattern remains the same

6 – TEXTURED CHROME CORNERS – while now finished in silver powdercoat, the casting is unchanged.

7 – NEW TABLE FINISH – CRESTWOOD LAMINATE – we typically only stock a laminate for 15-20 years at most, and 1981 was “a while back”.

And while not called out in the document, that table has the older-style down corners – also no longer available. Current model corners are black plastic, wider at the top and tapered toward the bottom.

CAN I USE THE CURRENT PARTS AND ADAPT THEM? This won't be a cost-effective solution on a 40 (or more) year old table worth possibly as much as the parts you'd need to put in. You will notice from the photo the door on the left is not as tall, but wider. You **CAN NOT** adapt the current parts to fit in an older table because the original hole will be too tall, and you'll have to widen it. We **STRONGLY RECOMMEND** you do not attempt this “upgrade.” You'd be better off finding a newer table with a broken slate, transferring your old slate to the not-as-old table, and pitching the leftovers.



BUT COULDN'T YOU CHECK TO MAKE SURE YOU DON'T HAVE A ____ STILL AVAILABLE? We're sure. In the many years since some of these model and color changes, if we haven't completely combed our stock and plundered every sample table we had, we have also moved—discarding a lot of long-discontinued pieces-- several times through the years (three times since 2005). We don't mean to be brutal

about it, but some folks get pretty ticked off that we no longer stock laminate colors or parts for coin doors not used in production for more than 35 years. They will argue that you can still buy parts for a Ford Truck from the 1960s, but the total number of Dynamo pool tables built over the past 40+ years is probably close to the total number of trucks Ford builds every month.

Considering just how many of our current parts still fit a table as old as 1981 (45 years) that's still pretty good.

WHAT SIZE IS MY TABLE? This chart will be very helpful.

The model number ("What we call it") will frequently be found stamped in the ball view door area of the table, or as part of that Serial Number we cannot use to determine the age.

IMPORTANT: avoid inconvenience, returns, restock fees and additional shipments; know your table's size before looking for parts. Never say "it's a bar table." **Not all bars are the same size, bar tables are different sizes too.** Ask if you are not sure.

HOW DOES SIZE MATTER WITH REGARD TO PARTS? : These items will all be the same size regardless of your table's size:

I HAVE A DYNAMO NON-COIN TABLE EITHER LIKE, OR IN THE STYLE OF, THE TABLES SHOWN IN THESE PHOTOS, DO YOU HAVE PARTS FOR THEM?



No

Not for close to 30 years. Very few were built, and Dynamo didn't build them, they were contract manufactured by a company that's since closed.



I HAVE A DYNAMO COIN TABLE EITHER LIKE, OR IN THE STYLE OF, THE TABLE SHOWN ON THIS BROCHURE, DO YOU HAVE PARTS FOR THEM?

Some parts yes, some no. Even fewer of these were built. Before placing ANY orders for parts, [contact Tech Support.](#)

COULD MY TABLE BE RARE AND VALUABLE ENOUGH TO RESTORE TO NEW CONDITION? We have sold many thousands of tables over the years. From a collectable standpoint, a 100% restored vintage Dynamo pool table is not a "winning lottery ticket." (not even a '5 out of 6 numbers') If you have a table you want to restore, don't

worry about getting it to accurate factory-new condition (and keep in mind, parts availability for older tables can be a problem). Have fun with your project and get it into a condition where you enjoy looking at it, playing on it, and bragging to your friends how hard you worked on it.

HOW MUCH IS MY TABLE WORTH? There is an OFFICIAL COMPANY POLICY with its own page to explain why we can't answer. See [THIS LINK](#)

I HAVE AN OLD DYNAMO TABLE IN PRETTY GOOD SHAPE, WOULD YOU WANT TO BUY IT BACK FROM ME FOR DISPLAY IN YOUR SHOWROOM? No thanks, we simply don't have the space. Nor do we even really have a showroom.



DO YOU SELL A KIT TO ADD A DBA TO MY PUSH CHUTE DYNAMO POOL TABLE (like the one in the photo)? No, the [Sedona DBA](#) table

- Has an LCD display in the top rail making it far easier to read
- Retains full push chute function in case of battery failure/discharge so the table can still be used.

We do not supply, endorse or support any 3rd party DBA-add-on kit.



CAN I ADAPT PARTS FROM THE CURRENT DYNAMO SEDONA DBA TO USE THE BILL-ACCEPTOR TO WORK ON MY DYNAMO DBA TABLE FROM THE EARLY 1990'S? No, for those tables only parts shared with current production, non-DBA tables will still be available.

CAN I USE THE [ZD-X UPGRADE KIT](#) OFFERED ON YOUR WEBSITE ON MY DYNAMO PRO PLUS? Yes, this kit will replace the PCB, harnessing, battery and charger and allow you to have all the additional options, program copying, league dues, reset button and battery protection

advantages of the Panther ZD-X software (also found on our [DYNAMO SEDONA DBA table](#)).



WILL PARTS FOR CURRENT VALLEY BUMPER POOL TABLES FIT MY DYNAMO BUMPER POOL TABLE? It surprised some longtime pre-merger employees that Dynamo made a Bumper Pool table at all—until we found some old photos. Aside from the familiar-looking legs and *MAYBE* the coin door, we’re pretty sure no currently-available Dynamo parts will work. Valley Bumper Pool cushions will *definitely* not fit; but with all tables, Bumper

Pool cushion rails can be removed, freshened with new rubber and recovered by nearly any pool table service professional.

I WANT TO MOVE MY TABLE, HOW DO I TAKE IT APART? Be careful: **POOL TABLES ARE VERY HEAVY**. Always overestimate how many people you will need to move your table. Many of our distributors can offer assistance in moving tables. They may provide the service, or be able to refer you to an experienced and capable mover.

The legs on our tables should be removed during the move. Also, the one-piece slate alone is close to half your table’s weight and almost guaranteed to be damaged if it comes loose during the move. You should remove it and move it separately. (first remove the metal trim around the sides of the table, then the bolts holding the cushion rails and the slate should lift out relatively easily, more detailed instructions are posted on this site). Disassembling a coin operated table any further is very risky, and your table is unlikely to ever be the same—if you can reassemble it afterwards at all.

WHAT CUE BALL DO I NEED?

Look directly to the left inside your Dynamo table’s Ball View Door opening.

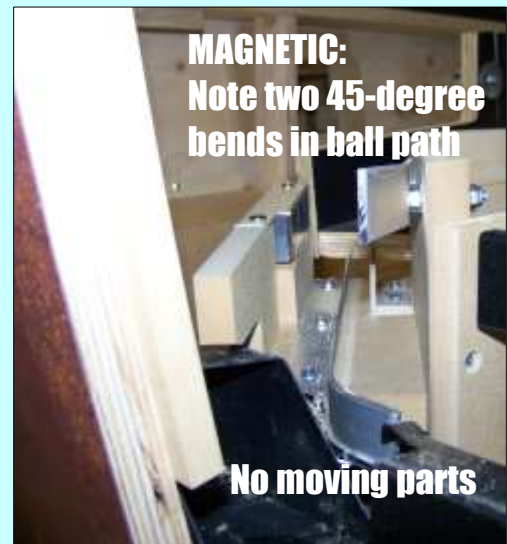


WEIGHTED:

Tables built prior to 1993 used a weighted cue ball and the separator (which has moving parts) looks like the photo on the left.

Tables built since 1995 use a magnetic cue ball. If you see something like this shot of the separator to the RIGHT, you’ve

likely got magnetic separation.

Note two 45-degree bends in ball path

No moving parts

Dynamo tables built between 1993 and 1995 could use either separator, depending on the customer placing the order.

Some cue balls will have marker dots on them to help with shot practice but *may not be weighted*. A common Postal scale should be sensitive enough to detect the weight difference between a weighted cue ball and the object balls. We stocked a weighted cue ball in our WebStore but finally depleted our inventory in August 2011 – 16 years since Dynamo last made a table using that ball. It weighed 6.6oz, a standard object ball weighs 5.7 to 5.8oz.

We use the [Valley® Cougar® Cue Ball](#) by Aramith in new tables. It is a 2¼ -inch perfectly balanced magnetic cue ball and weighs 5.7 to 5.8oz.

IS IT POSSIBLE TO CHANGE MY POOL TABLE FROM A WEIGHTED TO MAGNETIC CUE BALL SEPARATOR? While some creative individuals have ordered the [COMPLETE DYNAMO SEPARATOR ASSEMBLY](#) and adapted it for use in an older table, there is no official procedure for this, no refunds are offered if you give up mid-process, and we have no instructions available. Remember, the newest table with a weighted separator is almost 30 years old. Perhaps it's time for a new table?

MY DYNAMO POOL TABLE HAS A LIGHT IN THE BALL AREA, CAN I GET PARTS FOR IT? It has been about 30 years since those were used in production and close to that long since we had parts for them. Our hazy memories said the unit used a 9v battery and a 5v bulb. Try replacing those and no further fixes may be needed.

And before you ask, based on this we definitely don't have any light kits to add to an existing table.

COULD YOU SEND A PARTS BREAKDOWN SPECIFICALLY FOR MY TABLE? The best [Dynamo Pool Parts Breakdown](#) we have is posted. Available parts are hyperlinked, click on the part and you can see its pricing and purchase it.

This breakdown will not cover 30+ year old metal coin door models, or the billiard-style non-coin models, but practically everything shown is available.

HOW CAN I GET THE PERSONALIZED ATTENTION NEEDED TO DO A COMPLETE RESTORATION OF A TABLE? Although our Parts and Tech departments are knowledgeable and can answer a few questions, we are also very busy with the construction and support of new tables and simply lack the staff to provide step-by-step guidance. Sometimes you need someone local or close by who can look at things first hand, or that you may need to buy a lot of parts from piecemeal. While you can [USE OUR DEALER LOCATOR](#) to possibly find someone in your area, realize most Dealers are much more interested in selling new equipment than helping restore a decades-old, parts-*might-be-available* relic. Your



best bet is often to find others who have restored or are restoring old pool tables. The Internet is your friend.

THE PARTS FOR MY VERY OLD TABLE ARE NO LONGER AVAILABLE, HOW CAN I CUSTOMIZE IT TO MAKE IT WORK? Once again, we are very busy with the construction and support of new tables and simply lack the staff to provide step-by-step guidance. We refer to this as the “you need to get creative to keep it working” phase of ownership.

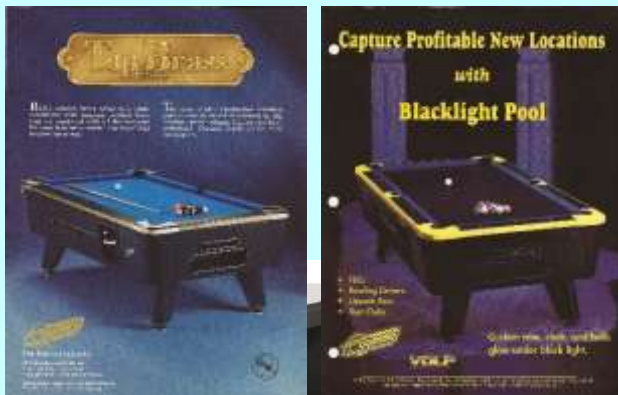
WHAT LAMINATE COLORS ARE CURRENTLY AVAILABLE? Our tables have come in a very wide variety of wood shades over the years but the colors available on the website – representing about the most recent 15 years of production—are all we currently stock.

If you want to restore a table in a different color, or get a laminate made to match what is currently on your table, we suggest contacting a cabinet refinisher. They normally have a vast selection of possible laminates to choose from.

We do not stock sheets of laminate for Dynamo tables. Not even for current production models. Dynamo tables use a thin laminate that is not easily shipped.

HOW DO I REPLACE THE WOOD LAMINATES? What we do at the factory for a new table is quite different from the steps needed to remove and replace the laminate on a fully-assembled table. We’ve posted a few tips [AT THIS LINK](#) but we’re not an educational source for woodworking. Best to check with someone who can teach you in person, hands-on.

ON YOUR WEBSITE THE SIDE AND END TRIM LISTED IS THE SAME AS FOR VALLEY. CAN I GET SIDE TRIM SPECIFICALLY FOR DYNAMO? Both tables use the same trim extrusion, and the length is the same within fractions of an inch. At most, on a Dynamo table you may need to drill new mounting screw holes, but Valley trim will work just fine. We try to keep the cost of the trim reasonable by not carrying stock of practically identical and interchangeable parts.



CAN WE STILL GET ANY BRASS (Top Brass) or FLUORESCENT (Blacklight Pool) TRIM? Afraid not, both tables have been out of production for at least 20 years, and the last of the trim was cleared out nearly 15 years ago.

A fully-enclosed Dynamo Pool table's coin mechanism consists of all of these parts. The Trigger Arm moves the Ball Stop, and holds the coin.

*Parts are no longer available for older Dynamo tables with Metal Coin Doors. You would need to track all the parts from this photo and adapt them to fit your table (the plastic door frame wider, but not as tall). For instructions, visit [www.pooltable.com](#), and while some have managed to make it work, we do not recommend attempting it.

CAN YOU HELP ME FIND OUT WHAT PARTS I NEED IN MY COIN MECHANISM? Describing

what your mechanism looks like and what it might or might not have will be of little help to us. We have a [VERY HANDY HYPERLINKED PHOTO](#) showing what the complete unit is supposed to look like and easily clickable links to purchase any parts shown.

If it doesn't look like what's in this photo, it's that older coin area discussed on page #4. For that, no parts are available or have been available for close to 30 years.

SOME REALLY OLD COIN MECHANISMS LOOK LIKE THIS PHOTO, CAN I STILL GET SOMETHING LIKE IT?

Monarch Coin produces an "old look" coin chute, called the Model 444. You don't have the price flexibility of a modern push chute, but you get the old-style look.



HOW CAN I CHANGE MY COIN-OP TABLE TO FREE PLAY? On more recent tables with vertical coin slots, there is a fairly simple process to change out the coin slots with "blanks" so you simply use the existing coin chute. Click for [An illustrated guide on how to do this](#) .

Another option on any table may be to disable the Ball Flap by removing it entirely or rigging it to stay in the up position. This way, the balls will simply roll through the trap without stopping and into the collection box. It might be more difficult than putting blanks into the push chute, but [E-mail Valley Dynamo Tech Support](#) for the procedure, to make sure it is done correctly.

It is tempting to jerry-rig the table so you can simply reach in and trip the trap to release the ball without using the push chute. If you remove any pieces, try to save them. There should be plenty of storage space available in the cavity of the table.

LET'S TALK KEYS

COULD I GET A KEY FOR MY OLD COIN DOOR? Not from Valley-Dynamo. For the owners' security, coin doors are randomly keyed and there is no "universal" key. To replace the lock, almost any 7/8" barrel lock ought to work on your coin door, almost all parts suppliers in the vending/game industry have them readily available for sale, and [we sell replacement locks in our Webstore](#).

COULD I GET A KEY FOR MY BALL VIEW DOOR OR CLEAN OUT DOOR? These keys are more readily available—**SO LONG AS NO PRIOR OPERATOR CHANGED THE LOCKS** (*Operators frequently change the locks to prevent someone with factory-issue keys for the factory-issue locks from playing unlimited free games on their tables*). We have no control over what lock an owner, operator, or location chooses to install in their table at some point between when it left our facility and when you got it.

Dynamo tables MAY use a #106, 2255 or 1155 lock – only the current [#106 key](#) and [locks](#) are still available. Bill-acceptor Dynamo tables may be equipped with [7515 locks](#). Locks and keys can be purchased from many parts distributors and on the WebStore,

and none are that expensive. Unless you are a locksmith or one owes you a favor, either will cost less than calling a Locksmith to make a key for your table.

There are absolutely no refunds if you order a key and it does not work, so proceed with caution.

There are absolutely no discounts or exceptions if you are ordering just one key

CAN I PURCHASE A NEW SLATE FOR MY TABLE? Slates are not cheap and, because they're incredibly heavy and will crack without proper protection and handling, are not cheap to ship. You are likely looking at around \$1000 for a slate delivered to a local truck terminal. Dynamo slate dimensions have remained unchanged for decades, are also the same as Valley slate dimensions, and likely other manufacturers have used slates of the same dimensions as well. Also, the only way a slate truly ever goes bad is to break. Your quickest and cheapest solution is often to contact a Vending Operator in your area. They usually have a warehouse stacked to the ceiling with dusty, cobwebbed, very old tables with slates the size you're looking for and will be thrilled to have you buy one and take it off their hands. Take the slate, take the parts you need, and have a bonfire with the rest or part it out on ebay or LetGo.

For every slate we sell, we usually get 10 requests for a "quote for insurance" – and upon settlement the person getting the quote likely does what we suggest and poaches an intact slate from an older table they got on the cheap (exactly as we recommended above). We sure don't hear from them. **Not wishing to be an accomplice to possible Insurance Fraud, company policy is we provide no slate quotes for insurance purposes other than the "about \$1000 plus shipping" as stated above.**



I NEED THAT PART IN THE LOWER PART OF THE PHOTO THAT HOLDS THE TRIPPER ARM IN PLACE. THAT PLASTIC RECTANGLE. We literally use the scrap plastic left when punching chalk-relief holes in the ball return ramps. Any piece of scrap plastic you can find locally will do the job just fine. It would literally cost more to ship the part than the price of the part.

As with a lot of hardware bits on a Dynamo table, we are not bolting important stuff on an airplane here. While there are plenty of special Dynamo-only parts you'll need to keep things working, this is very much a case of "anything that looks like it'll work, probably will. If it doesn't, just find something else that looks like it'll work."



SHOULD I REPLACE MY CUSHION RAILS? For commercial locations we recommend replacing rails every other year. Rails used on a home table see less usage—unless you keep that table seriously busy-- but the rubber will begin to dry out and crack after 10 years. Unless the previous owner knows for sure, assume the rails on a newly-acquired old table probably need replacement, and then you will know exactly how old they are.

WILL NEW RAILS REALLY FIT MY OLD TABLE? We've recently gone to a single cushion rail suitable for Dynamo AND Valley tables. For current production models they are absolutely interchangeable, and unlike Valley tables the location of the rail bolt holes never changed on Dynamo tables so the “three bolt holes that matter” will be in the correct place.

The down side of this is it may be necessary to shave or sand about 1/8” from the bottom of the wood for these rails to fit properly on older-model Dynamo tables (prior to 2000) – as you may have difficulty mounting them “low enough”. If you're unsure, we recommend ordering uncovered rails so you avoid having to uncover, cut them down, and recover.

Even though your table is a Dynamo, it's a good idea to review pages 8 and 9 of our [Valley Cushion Rail Service Guide](#) as it contains specific mounting specifications. Improper cushion rail height can have a huge effect on your table's playability.

WHAT IS THE TORQUE SPEC FOR RAILS? We tighten rails to **65 inch-pounds**, but for consistent quality play it is far more important that rails are properly aligned.

I'VE ONLY GOT ONE DEAD RAIL; WHY CAN'T I JUST BUY ONE REPLACEMENT? For several reasons, all good:

- Mixing old and new rails on a table is almost certain to result in inconsistent play. What was your one dead rail is now one rail years newer than the others.
- Rails come in different profiles and rubber configurations which will have different play characteristics even if they are the same age.
- Replace just one, and you are likely to have a different dead rail a few months later and have to go through the whole process again.
- The dye lot of a single rail may be just enough from the others to be obvious.
- Left side, right side, and end rails are all different. Practically every time someone tries to get “just one”, it ends up being wrong.

This is not a conspiracy to force you to buy rails by the set, not more than why shoe stores only sell shoes in pairs. They will match, they'll look like they match, and you'll know the age of all six rails on your table.

WHAT SHOULD I KNOW WHEN ORDERING CUSHION RAILS? Be sure you know for certain...

- The size of the table
- If your Dynamo table is newer than 2000 (can use the current “Universal” rails) or older than 2000 (will need to shave about 1/8” of wood from the

bottom of the “Universal” rails) or get old of the “old style” rails while supplies last

- If you want original equipment or Ridgeback® rails.
- If you want OEM rails : uncovered, or pre-covered in Tournament Green Mercury Ultra felt.

The parts breakdowns located under Dynamo Pool and the [Quick Guide to Rail sets](#) on the site will list part numbers for all available rail sets. Uncovered rail sets with K-66 profile rubber are available for all Dynamo table sizes except 9-foot but covered Dynamo rails are only available for 6½-foot, 7-foot and 8-foot tables.

We have not studied other manufacturer’s tables to determine if our parts fit.

CAN I BUY PARTS FROM YOU? Anyone with a major credit card or PayPal account may purchase from the Valley-Dynamo Webstore. You don’t have to be a Dealer

However, we only accept parts orders via the WebStore – no verbal / call-in orders.
